



Rockbridge Area Master Gardeners Association Grant Criteria Eligibility

Eligibility:

- Must be a Rockbridge County Virginia nonprofit organization including but not limited to schools, community centers, rehabilitation facilities, nursing homes and public libraries.
- Projects should align with RAMGA's mission statement. Examples would be native, pollinator and natural
 habitat planting, fruit or vegetable gardens, public gardens (vegetable and flower), raising plants for sale
 (4-H), composting, purchasing plant labels and gardening tools or similar that are considered to have
 educational value, reduce food insecurity, or have a positive environmental impact (which could include
 removal of invasive plants)
- Projects must not use/introduce invasive plants
- Project must take place on public or nonprofit-owned property
- Awardees are expected to provide updates and a post project presentation to the Grant Committee

Award Amount:

- Minimum of \$100.00 and maximum of \$400.00
- RAMGA reserves the right to partially fund projects
- Applications are accepted once every 3 years for repeat applicants

Application Requirements:

Signed letter of support from School Principal for all school projects

Reporting and Compliance:

- All applications must be complete in order to be eligible
- Incomplete applications will be deemed to be ineligible
- RAMGA reserves the right to partially fund any award
- Award funds are to be used solely for garden expenses including tools, plants and seeds, plant stakes and other material needed for planting
- Award funds may not be used for indirect expenses like food, travel, computers, cameras, software, speaker fees, salaries or field trips
- Awardee must complete a post award report. Failing to do so will make them ineligible for future awards.

Awardee holds full legal and financial responsibility for its project.
